
#### Key West defines citizens as free white people

No. 14. An ACT to incorporate the City of Key West. Be it enacted by the Governor and Legislative Council of the Territory of Florida, That all the free white male innibitants of that part of the island of Key West, comprehended within the i mits prescribed by the plan of said town, no v on ale in the Inhabitants of clerks office in the county of Monroe, be and they are hereby Key- stin constituted a pody corporate and politic, by the name and style of the city of Key West, and by their corporate name may sue and be sued, plead and be impleaded, grant and receive donations, and do all other acts as natural persons, and may purchase and hold real, personal and mixed property, and cispose Name & powof the same for the benefit of the said city, and may have and ers.
